**Subject: Letter of Intent for Skill-based training programs to be conducted for students.**

- d. Providing course material to undergoing training candidates.
- e. Taking assessment and providing certificates to each candidate.
- f. Upon successful completion of training BSE Institute Limited in best effort basis will provide placement opportunities to candidates.
- g. BSE Institute will also encourage candidates to pursue entrepreneurial opportunity as Mutual Fund advisor, Insurance advisor or Banking Correspondent as case may be.


**B. Responsibilities of College**


