NOTICE

The 3rd In-Person Counselling Schedule (Annexure - A) is hereby published for the information of all registered students who are eligible for consideration against the available leftover seats.

All concerned students are required to **strictly adhere to the schedule, reporting time, venue, and instructions** issued in this regard.

1. Candidates must report personally at the designated counselling venue at least 15 minutes before the scheduled time of their counselling session. Late reporting may result in non-consideration of the candidate.
2. Candidates must bring all original documents/certificates required for admission and physical verification. The documents shall be verified at the time of counselling in case a seat is allotted.
3. Failure to appear in person at the designated venue on the allotted date and time shall result in forfeiture of the candidate's claim for admission, even if the candidate otherwise falls higher in the merit list.
4. Admission shall be offered strictly on the basis of merit, programme eligibility, applicable reservation rules and availability of vacant seats, subject to successful verification of original documents.
5. Merely registering or submitting programme preferences does not confer any right to admission. Admission shall be confirmed only after counselling, physical verification of documents and completion of all prescribed admission formalities.
6. Candidates to whom a seat is allotted must complete the admission formalities and deposit the prescribed fee within the stipulated time. Failure to do so may result in cancellation of the allotted seat.
7. Candidates must ensure that the original documents produced for verification are genuine, valid and complete. Admission shall be liable to cancellation if any discrepancy or misrepresentation is detected.
8. Candidates are advised to carefully check their programme, counselling date, session, time and venue before reporting to the College.
9. No claim for consideration shall be entertained from a candidate who fails to report within the prescribed counselling session, and the vacant seat may be offered to the next eligible candidate as per merit.
10. The decision of the Counselling/Admission Committee regarding eligibility, document verification and allotment of seats shall be final, subject to the applicable admission rules and regulations.
